PR-4 HONORING VERNON A. CORREA (WAR MEMORIAL BASEBALL FIELD NO. 3)

DESCRIPTION: The Committee is in receipt of Bill No. 32 (2001), transmitted by the County Clerk, entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, RELATING TO NAMES OF PUBLIC FACILITIES, TO DESIGNATE THE VERNON A.
