PR-8 FEES AND REGULATIONS FOR OCEAN RECREATIONAL ACTIVITIES PERMITS

DESCRIPTION: The Committee is in receipt of a Miscellaneous Communication, from the County Clerk, dated May 21, 2001, referring the matter relating to fees for ocean recreational activity permits (Ch. 5.24, Maui County Code).

STATUS: At its meetings of September 19, 2001 and December 5, 2001, the Committee deferred action pending further discussion. On September 19, 2001, the Committee discussed the potential establishment of regulations and permit fees for businesses wishing to obtain Ocean Recreational Activity Permits. On December 5, 2001, the Committee heard a presentation reviewing self-regulations of ocean recreational activities for surfing, windsurfing, and kite boarding schools. The Committee may consider the existing permit fees and the possible regulation of ocean recreational activities. The Committee may also consider other related action, including the possible filing of the Miscellaneous Communication.

PR-16 MATTER RELATING TO THE CREATION OF ADDITIONAL CAMPSITES

DESCRIPTION: The Committee is in receipt of County Communication No. 01-204, from the Mayor, requesting consideration of a matter relating to the creation of additional campsites within the County.

STATUS: At its meeting of February 13, 2002, the Committee received a presentation recommending various locations as potential campsites. The Committee deferred action pending further discussion. The Committee may discuss the status of Papalaua Wayside Park campsite and review proposed locations for creating additional campsites. The Committee may also consider other related action, including the possible filing of County Communication No. 01-204.
