DESCRIPTION:

The Committee is in receipt of County Communication No. 01-327, from Councilmember Wayne K. Nishiki, transmitting a letter from a constituent relating to a request for the installation of a traffic light at the intersection of Pi'ikea Street and Liloa Street in Kihei.

STATUS:
