AUTHORIZING A GRANT OF A LICENSE TO USE COUNTY REAL PROPERTY ALONG MAMALU PLACE AND MAOHU STREET, MAKAWAO

DESCRIPTION:

The Committee is in receipt of County Communication No. 02-21, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "AUTHORIZING A GRANT OF A LICENSE TO USE COUNTY REAL PROPERTY IN MAKAWAO, MAUI, HAWAII TO JOEL ANTHONY KENNEY". The purpose of the proposed resolution is to authorize a grant of a license to Joel Anthony Kenney to use County real property along Mamalu Place and Maohu Street, Makawao, for the encroachment of a wall and walkway on the County right-of-way.

STATUS:

The Committee may decide to reconsider their previous recommendation to adopt the proposed resolution as revised. PWT-10 RENAMING EXISTING STREETS

DESCRIPTION: The Committee is in receipt of County Communication No. 02-188, from the Chair of the Public Works and Transportation Committee, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 2.38, MAUI COUNTY CODE, RELATING TO RENAMING EXISTING STREETS". The purpose of the proposed bill is to establish (1) a process for renaming of existing streets; and (2) a public safety exception to improve the response of authorized emergency personnel.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 02-188.

PWT-12 CONSIDERATION OF TRAFFIC LIGHT REQUEST FOR THE INTERSECTION OF PI'IKEA STREET AND LILOA STREET IN KIHEI

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 01-327, from Councilmember Wayne K. Nishiki, transmitting a letter from a constituent relating to a request for the installation of a traffic light at the intersection of Pi'ikea Street and Liloa Street in Kihei; and
2. Correspondence dated October 11, 2002, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.44, MAUI COUNTY CODE, PERTAINING TO STOP REQUIRED". The purpose of the proposed bill is to authorize the installation of a permanent four-way stop at the intersection of Pi'ikea Street and Liloa Street in Kihei.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 01-327..

PWT-29 RELATING TO ON-STREET PARKING LIMITS

DESCRIPTION: The Committee is in receipt of County Communication No. 02-166, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO ON-STREET PARKING IN THE WAILUKU DISTRICT". The purpose of the proposed bill is to establish timed parking on both sides of Kaohu Street between South Market Street and Spreckels Ditch before the Kaohu Store.

STATUS: The Committee requested additional information relating to off-street parking requirements for the Iao Intermediate School renovation project. The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 02-166.

PWT-61 ACCEPTING DEDICATION OF ROAD WIDENING LOT FOR BOTEILHO ESTATE 3

DESCRIPTION: The Committee is in receipt of County Communication No. 02-212, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT 5-D FOR THE BOTEILHO ESTATE 3 (FKA BAYONG SUBDIVISION) PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of road widening lot along Omaopio Road, Kula, TMK (2) 2-3-003:128.

PWT-45 REUSE OF RECLAIMED WATER FOR IRRIGATION PURPOSES

DESCRIPTION: The Committee is in receipt of County Communication No. 02-157, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR ORDINANCE AMENDING CHAPTER 20.30, MAUI COUNTY CODE, PERTAINING TO REUSE OF RECLAIMED WATER FOR IRRIGATION PURPOSES". The purpose of the proposed bill is to expand the requirement for R-1 reclaimed water utilized by commercial properties for irrigation purposes to Central Maui.
