### **PROPOSED BILL AMENDING CHAPTER 10.36, PERTAINING TO SPEEDING RESTRICTIONS**

**DESCRIPTION:** The Committee is in receipt of County Communication No. 02-235, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.36, MAUI COUNTY CODE, PERTAINING TO SPEED RESTRICTIONS". The purpose of the proposed bill is to raise the speed limit from 20 mph to 25 miles per hour along Waiale Drive between Wai'inu Road and Kuikahi Drive in Wailuku.

**STATUS:** The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 02-235 or referral to the Council Chair for the term beginning January 2, 2003.
