Chair and Members:

Your Public Works and Transportation Committee, having met on February 13, 2002, makes reference to County Communication No. 01-330, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "AUTHORIZING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 15-C, from the Kahanu Family Limited Partnership, along Naalae Road and Homestead Road, Kula, Maui, Hawaii.

By correspondence dated February 6, 2002 to the Corporation Counsel, your Committee Chair requested that the title of the proposed resolution be revised to be more specific, distinguishing the subject legislation from other legislation on similar matters.

By correspondence dated February 7, 2002, the Department of the Corporation Counsel transmitted a revised resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT FOR KAHANU FAMILY LIMITED PARTNERSHIP, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The resolution was revised to incorporate reference to the Kahanu Family Limited Partnership.

At its meeting, your Committee met with the Director of Public Works and Waste Management, and a Deputy Corporation Counsel.

The Director of Public Works and Waste Management provided a brief overview of the matter. He indicated that road widening Lot 15-C is approximately 5,700 square feet in size.
