PROPOSED BUDGET FOR FISCAL YEAR 2003 FOR THE COUNTY OF MAUI

DESCRIPTION:

The Committee is in receipt of County Communication No. 01-244, from the Chair of the Budget and Finance Committee, relating to the matter of the proposed budget for Fiscal Year (FY) 2003.
