DISTRICT BOUNDARY AMENDMENT AND CHANGE IN ZONING FOR HANA COMMUNITY HEALTH AND WELLNESS VILLAGE

DESCRIPTION:

The Committee is in receipt of County Communication No. 06-313, from the Planning Director, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND THE STATE LAND USE DISTRICT CLASSIFICATION FROM AGRICULTURAL TO RURAL FOR PROPERTY SITUATED AT HANA, MAUI, HAWAII". The purpose of the proposed bill is to grant a request from Hana Community Health Center, Inc. for a District Boundary Amendment from Agricultural to Rural for approximately 9.501 acres (TMK: (2) 1-4-03:022 (por.)), to allow for the expansion of the existing Hana Community Health Center in Hana, Maui, to be known as the Hana Community Health and Wellness Village.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE TO CHANGE ZONING FROM INTERIM DISTRICT TO PUBLIC/QUASI-PUBLIC DISTRICT (CONDITIONAL ZONING) FOR PROPERTY SITUATED AT HANA, MAUI, HAWAII". The purpose of the proposed bill is to grant a request from Hana Community Health Center, Inc. for a Change in Zoning from Interim District to P-1 Public/Quasi-Public District for approximately 12.108 acres (TMK: (2) 1-4-03:022 and (2) 1-4-03:024), to allow for the expansion of the existing Hana Community Health Center in Hana, Maui, to be known as the Hana Community Health and Wellness Village.

STATUS: The Committee will view the property and the surrounding area. No legislative action will be taken.
