BF-22 KUALAPUU VILLAGE SUBDIVISION FUND

DESCRIPTION: The Committee is in receipt of County Communication No. 01-224, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE REPEALING CHAPTER 3.60, MAUI COUNTY CODE, PERTAINING TO KUALAPUU VILLAGE SUBDIVISION FUND" (referred by the Public Works and Transportation Committee through Committee Report No. 01-176). The purpose of the proposed bill is to repeal Chapter 3.60 of the Maui County Code, relating to the Kualapuu Village Subdivision Fund since the purpose of the fund no longer exists.
