Chair and Members:

Your Budget and Finance Committee, having met on January 29, 2002, makes reference to County Communication No. 02-17, from the Budget Director, transmitting the following:

1. A proposed resolution entitled "AUTHORIZING ACCEPTANCE OF A DONATION FROM CHELCIE S. JONKE TO THE DEPARTMENT OF FIRE CONTROL, COUNTY OF MAUI, PURSUANT TO SECTION 13-8, REVISED CHARTER OF THE COUNTY OF MAUI (1983), AS AMENDED, AND CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to authorize the acceptance of a \$250 cash donation from Chelcie S. Jonke to the Department of Fire Control for the Hana Fire Station.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2002 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE DEPARTMENT OF FIRE CONTROL".

The purpose of the proposed bill is to amend Appendix A, Part I, of the Fiscal Year 2002 Budget, relating to grant revenues, to appropriate \$250 from Chelcie S. Jonke to the Department of Fire Control.

At its meeting, your Committee met with the Budget Director, the Fire Chief, and the First Deputy Corporation Counsel.

The Budget Director informed your Committee that Mrs. Jonke's husband had passed away last November in a drowning incident in Hana, and Mrs. Jonke

was making the donation to the Hana Fire Station in appreciation of the Department's efforts.

The Fire Chief expressed the Department's condolences to Mrs. Jonke and their appreciation for her thoughtfulness. He informed your Committee that the search for Mr. Jonke's body in one of Hana's streams was a difficult one for the Department. The firefighters' efforts to locate Mrs. Jonke's husband provided closure to her in a difficult time.

Your Committee requested that a letter be sent to the Fire Chief thanking the Hana Fire Station for a job well done. In addition, your Committee requested that a letter also be sent to Mrs. Jonke expressing the Council's appreciation for her kind gesture.

Your Committee requested that the proposed bill be revised to specify that the \$250 appropriation is for the Hana Fire Station since the donation was earmarked for the Hana Fire Station.

Your Committee voted to recommend adoption of the proposed resolution, passage of the revised proposed bill on first reading, and filing of the communication.

Your Committee is in receipt of a revised proposed bill incorporating your Committee's suggested revisions.
