Chair and Members:

Your Public Services Committee, having met on June 3, 2009, makes reference to County Communication No. 09-97, from the Director of Housing and Human Concerns, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION OF \$1,000 FROM ELLEN F. CRAWFORD TO THE COUNTY OF MAUI, DEPARTMENT OF HOUSING AND HUMAN CONCERNS, KAUNOA SENIOR SERVICES, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to authorize the acceptance of a \$1,000 cash donation from Ellen F. Crawford to the Kaunoa Senior Services Division, Department of Housing and Human Concerns, to provide additional services for participants of Kaunoa's Meals on Wheels program.

Your Committee notes that pursuant to Chapter 3.56, Maui County Code, the Council may accept gifts and donations on behalf of the County by resolution.

The Director of Housing and Human Concerns stated that Ms. Crawford was grateful for the services provided to the late Ellen F. Minkler by Kaunoa Senior Services' Meals on Wheels program, and wished to make the donation to allow the Department to assist others in need.

Your Committee voted 5-0 to recommend adoption of the proposed resolution and filing of the communication. Committee Chair Nishiki, Vice-Chair Pontanilla, and members Johnson, Medeiros, and Victorino voted "aye". Committee members Mateo and Kaho`ohalahala were excused.

BE IT RESOLVED by the Council of the County of Maui:


