PROHIBITION OF ALCOHOL AT CHARLEY YOUNG PARK (KIHEI)

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 09-78, from Councilmember Jo Anne Johnson, relating to the matter of prohibiting alcohol within the boundaries of Charley Young Park.
2. Correspondence dated March 13, 2009, from Councilmember Johnson, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 13.04, MAUI COUNTY CODE, PROHIBITING CONSUMPTION OF ALCOHOL AT CHARLEY YOUNG PARK". The purpose of the proposed bill is to prohibit the consumption of any intoxicating liquor, as defined in Section 281-1, Hawaii Revised Statutes, while within the boundaries of Charley Young Park, located at 2200 South Kihei Road, Kihei, Maui.
