### "READY TO GO" WATER-RELATED PROJECTS

**DESCRIPTION:** The Committee is in receipt of County Communication No. 09-49, from Councilmember Michael P. Victorino, requesting a status report from the Department of Water Supply on the water-related projects listed in a press release dated December 9, 2008, and entitled "Mayor Tavares Proposes 'Ready to Go' Projects in Support of U.S. Conference of Mayors' Main Street Recovery Plan".

**WR-1(5) WATER SUPPLY RULES (SUBDIVISION WATER SYSTEM REQUIREMENTS)**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. Correspondence dated October 11, 2006, from the Department of the Corporation Counsel, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 14, MAUI COUNTY CODE, RELATING TO PUBLIC SERVICES". The purpose of the draft bill is to codify rules and regulations of the Department of Water Supply.
2. Correspondence dated June 29, 2009, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 14.05, MAUI COUNTY CODE, RELATING TO PUBLIC SERVICES". The purpose of the proposed bill is to codify rules and regulations of the Department of Water Supply relating to subdivision water system requirements.

**STATUS:**

The Committee may consider whether to recommend passage of the proposed bill with or without revisions. The Committee may also consider other related action.
