FLOOD HAZARD AREAS

DESCRIPTION:

The Committee is in receipt of County Communication No. 09-219, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.62, MAUI COUNTY CODE, PERTAINING TO FLOOD HAZARD AREAS".
