Count 1. On April 8, 2009 at approximately 6:04 p.m., ZEEBIRD LTD. dba SOUTH SHORE TIKI LOUNGE, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2010-08, PLEA: NO CONTEST

In the matter of the accusation against KIMO'S PARTNERSHIP, LLC dba KIMO'S RESTAURANT, Restaurant General License No. 282, 845 Front Street, Lahaina, Maui, Hawaii.

Count 1. On June 13, 2009 at approximately 11:46 p.m., KIMO'S PARTNERSHIP, LLC dba KIMO'S RESTAURANT, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
