### WATER SUPPLY RULES (DEFINITION FOR AGRICULTURAL CONSUMER)

#### DESCRIPTION:

The Committee is in receipt of correspondence dated October 29, 2009, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 14.01.040, MAUI COUNTY CODE, TO ADD A DEFINITION FOR AGRICULTURAL CONSUMER". The purpose of the proposed bill is to add a definition for an agricultural consumer to Article 1, Title 14, Maui County Code (County Water Code).

#### STATUS:

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider other related action.
