## GENERAL PLAN UPDATE

### DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 07-54, from Councilmember Gladys C. Baisa, relating to the General Plan Update.
2. Correspondence dated February 21, 2008, from the Council Chair, transmitting the draft Countywide Policy Plan and the related recommendations of the Lanai General Plan Advisory Committee (GPAC), Maui GPAC, Molokai GPAC, Lanai Planning Commission, Maui Planning Commission, and Molokai Planning Commission, submitted by the Department of Planning pursuant to Chapter 2.80B, Maui County Code.
3. Correspondence dated July 24, 2009, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.80B.030, MAUI COUNTY CODE, RELATING TO THE GENERAL PLAN AND

MORE →

COMMUNITY PLANS". The purpose of the proposed bill is to adopt the Countywide Policy Plan, pursuant to Chapter 2.80B, Maui County Code, including the following elements: a vision for the County; a statement of core themes or principles for the County; and a list of countywide objectives for population, land use, the environment, the economy, and housing.

4. Correspondence dated October 23, 2009, from the Planning Director, requesting revisions to the proposed bill, including the addition of a glossary and sections respectively entitled "Introduction", "Maui County Today", "Key Strategies", and "Next Steps – Implementation".

**STATUS:**

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication No. 07-54 and other related action.
