Chair and Members:

Your Infrastructure Management Committee, having met on November 30, 2009, makes reference to County Communication No. 09-231, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.040, MAUI COUNTY CODE, PERTAINING TO PROHIBITED PARKING IN MOLOKAI DISTRICT".

The purpose of the proposed bill is to prohibit parking on both sides of Alohi Street, from its intersection with Kamoi Street for a distance of 200 feet to the east.

The Director of Public Works informed your Committee that at its meeting of August 4, 2009, the Traffic Safety Council recommended that parking be prohibited on a portion of Alohi Street, particularly in the area of the post office located on the north side of Alohi Street, in order to improve the flow of traffic.

Your Committee voted 7-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Medeiros, Vice-Chair Pontanilla, and members Baisa, Kaho'ohalahala, Mateo, Molina, and Victorino voted "aye".

Your Infrastructure Management Committee **RECOMMENDS** the following:

1. That Bill No. _____ (2009), attached hereto, entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.040, MAUI COUNTY CODE, PERTAINING TO PROHIBITED PARKING IN MOLOKAI DISTRICT", be **PASSED ON FIRST READING** and be **ORDERED TO PRINT**; and
2. That County Communication No. 09-231 be **FILED**.

A BILL FOR AN ORDINANCE AMENDING SECTION
10.48.040, MAUI COUNTY CODE, PERTAINING TO
PROHIBITED PARKING IN MOLOKAI DISTRICT

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 10.48.040, Maui County Code, is amended by
amending subsection F to read as follows:

"F. Molokai District.


1. On both sides of Ailoa Street in
Kaunakakai, Molokai, for a distance of fifty feet
on both sides of the crosswalk fronting Kaunakakai
School cafetorium, provided, that such prohibition
shall be only during school days during the hours
of seven a.m. to three-thirty p.m.

2. On both sides of Alohi Street from its
intersection with Kamoi Street for a distance of
two hundred feet to the east."

SECTION 2. New material is underscored. In printing this
bill, the County Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its
approval.
