A. COMPLAINT AND ACCUSATION NO. 2010-02, PLEA: NO CONTEST

In the matter of the accusation against CANE FIRE MAUI LLC dba LULU'S SURF CLUB & GRILL LAHAINA, Dispenser General License No. 218, 1221 Honoapiilani Highway, Unit A, Lahaina, Maui, Hawaii.

Count 1. On January 10, 2009 between the approximate times of 10:30 p.m. and 12:00 midnight, CANE FIRE MAUI LLC dba LULU'S SURF CLUB & GRILL LAHAINA, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Kimberly Domingo, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2010-14, PLEA: GUILTY

In the matter of the accusation against MAUI CHEMICAL AND PAPER PRODUCTS, INC. dba MAUI CHEMICAL AND PAPER PRODUCTS, Retail General License No. 237, 875 Alua Street, Wailuku, Maui, Hawaii.

Count 1. On May 29, 2009 at approximately 1:06 p.m., MAUI CHEMICAL AND PAPER PRODUCTS, INC. dba MAUI CHEMICAL AND PAPER PRODUCTS, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2010-15, PLEA: NO CONTEST

In the matter of the accusation against FUJIYAMA ENTERPRISES II, INC. dba TOM'S MINI MART, Retail General License No. 053, 372 Waiehu Beach Road, Wailuku, Maui, Hawaii.

Count 1. On May 29, 2009 at approximately 1:39 p.m., FUJIYAMA ENTERPRISES II, INC. dba TOM'S MINI MART, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

D. COMPLAINT AND ACCUSATION NO. 2010-16, PLEA: GUILTY

In the matter of the accusation against WBP, LLC dba SUPERSTOP, Retail General License No. 139, 270 Waiehu Beach Road, Wailuku, Maui, Hawaii.

Count 1. On May 29, 2009 at approximately 3:12 p.m., WBP, LLC dba SUPERSTOP, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
