In the matter of the accusation against WARD, LLC dba MANA'E GOODS AND GRINDZ, Retail General License No. 157, 8615 Kamehameha V Highway, Pukoo, Molokai, Hawaii.

Count 1. On July 15, 2009 at approximately 9:39 a.m., WARD, LLC dba MANA'E GOODS AND GRINDZ, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2010-20, PLEA: NO CONTEST

In the matter of the accusation against LISANDRA, INC. dba GIAN DON'S ITALIAN BISTRO, Dispenser General License No. 188, 1445 South Kihei Road, Kihei, Maui, Hawaii.

Count 1. On May 30, 2009 at approximately 10:28 p.m., LISANDRA, INC. dba GIAN DON'S ITALIAN BISTRO, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
