AMENDING LIST OF EXCEPTIONAL TREES

DESCRIPTION:

EAR-15 PROHIBITING AERIAL ADVERTISING

DESCRIPTION: The Committee is in receipt of County Communication No. 09-162, from Councilmember Jo Anne Johnson, transmitting a proposed bill entitled “A BILL FOR AN ORDINANCE AMENDING TITLE 20, MAUI COUNTY CODE, TO PROHIBIT AERIAL ADVERTISING”.
