### **WATER SUPPLY RULES (DEFINITION OF AGRICULTURAL CONSUMER)**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. Water Resources Committee Report No. 10-43 (recommitted), recommending passage on first reading of a proposed bill relating to the definition of "agricultural consumer".
2. Correspondence dated June 21, 2010, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING ARTICLE 1, TITLE 14, MAUI COUNTY CODE, RELATING TO AGRICULTURAL CONSUMERS". The purpose of the revised proposed bill is to add a definition for "agricultural consumer" to Article 1, Title 14, Maui County Code (County Water Code).

**STATUS:**

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of Committee Report No. 10-43 and other related action.
