**WAIVING CERTAIN PARK DEDICATION REQUIREMENTS FOR THE
E PAEPAE KA PUKO'A SUBDIVISION (PAIA)**

DESCRIPTION:

The Committee is in receipt of County Communication No. 08-46, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "WAIVER OF COMFORT STATION AND PARKING AREA REQUIREMENTS IN THE E PAEPAE KA PUKO'A SUBDIVISION, PAIA, MAUI, HAWAII, PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE". The purpose of the proposed resolution is to approve the waiver of requirements to provide comfort stations and parking areas in a privately owned and maintained park in the E Paepae Ka Puko'a Subdivision, Paia, Maui, consisting of approximately 1.942 acres, TMK: (2) 3-8-02:009 and TMK: (2) 3-8-01:portion of 003.
