## **BILL TO PROHIBIT PARKING ON WAILANI STREET, WAILUKU**

### **DESCRIPTION:**

The Committee is in receipt of County Communication No. 09-232, from the Director of Public Works, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.040, MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING ON WAILANI STREET, WAILUKU". The purpose of the proposed bill is to prohibit parking on a portion of Wailani Street in Wailuku, between East Vineyard Street and Nani Street.
2. Correspondence dated June 15, 2009, from Thomas Thomas, Chair, Traffic Safety Council, to the Director of Public Works, recommending approval of the request to prohibit parking on a portion of Wailani Street, Wailuku.
