Chair and Members:

Your Public Services Committee, having met on August 4, 2010, makes reference to County Communication No. 10-137, from the Chief of Police, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION FROM THE MAUI POLICE RELIEF ASSOCIATION, TO THE COUNTY OF MAUI, DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the donation of fitness equipment, specifically three Hammer Strength fitness machines valued at approximately \$5,875.65.

Your Committee notes that pursuant to Chapter 3.56, Maui County Code, the Council may accept gifts and donations on behalf of the County by resolution.

According to the Assistant Chief, Department of Police, the Maui Police Relief Association purchased the fitness equipment for use by the employees of the Department of Police. The equipment was delivered to the Department and is currently in use.

Your Committee voted 7-0 to recommend adoption of the proposed resolution and filing of the communication. Committee Chair Nishiki, Vice-Chair Pontanilla, and members Johnson, Kaho`ohalahala, Mateo, Medeiros, and Victorino voted "aye".

Your Public Services Committee RECOMMENDS the following:

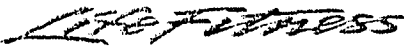

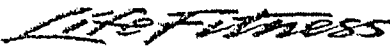
