Chair and Members:

Your Public Services Committee, having met on August 4, 2010, makes reference to County Communication No. 10-147, from the Chief of Police, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION FROM THE DEPARTMENT OF THE ATTORNEY GENERAL, HAWAII INTERNET CRIMES AGAINST CHILDREN TASKFORCE, TO THE COUNTY OF MAUI, DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept a donation from the Department of the Attorney General, Hawaii Internet Crimes Against Children Taskforce, of various computer equipment valued at \$3,350.

Your Committee notes that pursuant to Chapter 3.56, Maui County Code, the Council may accept gifts and donations on behalf of the County by resolution.

According to a Captain from the Criminal Investigation Division, Department of Police, the donation of two computer laptops, software, and related accessories was made at the conclusion of specialized training provided by the Department of the Attorney General to detectives from Maui working with the Department. He stated that the equipment will enable the detectives to fight internet crimes against children.

Your Committee voted 7-0 to recommend adoption of the proposed resolution and filing of the communication. Committee Chair Nishiki, Vice-Chair Pontanilla, and members Johnson, Kaho`ohalahala, Mateo, Medeiros, and Victorino voted "aye".



approximately valued at \$3,350 to the County of Maui, Department of Police; and


WHEREAS, Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,
