In the matter of the accusation against IZAKAYA MATSU LLC dba IZAKAYA MATSU, Restaurant General License No. 168, 1280 South Kihei Road, Suite 120, Kihei, Maui, Hawaii.

Count 1. On June 24, 2010 at approximately 7:16 p.m., IZAKAYA MATSU LLC dba IZAKAYA MATSU, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2011-02, PLEA: NO CONTEST

In the matter of the accusation against FOODS 4 LIFE INC. dba RODEO GENERAL STORE, Retail General License No. 306, 3661 Baldwin Avenue, Makawao, Maui, Hawaii.

Count 1. On June 4, 2010 at approximately 8:16 p.m., FOODS 4 LIFE INC. dba RODEO GENERAL STORE, a retail general licensee, did, through its employee, sell or furnish liquor to minors, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2011-03, PLEA: NO CONTEST

In the matter of the accusation against MH ENTERPRISES, INC. dba KOBE JAPANESE STEAK HOUSE, Restaurant General License No. 155, 136

Dickenson Street, Lahaina, Maui, Hawaii.

Count 1. On June 11, 2010 at approximately 7:38 p.m., MH ENTERPRISES, INC. dba KOBE JAPANESE STEAK HOUSE, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
