CHAPTER 201H, HAWAII REVISED STATUTES, AFFORDABLE HOUSING PROJECTS (KULA RIDGE AFFORDABLE HOUSING SUBDIVISION PROJECT)

DESCRIPTION:

The Committee is in receipt of the following:

1. Correspondence dated September 8, 2010, from the Director of Housing and Human Concerns, transmitting the following:
 - a. An application for the development of the proposed Kula Ridge Affordable Housing Subdivision Project in Kula, Maui, Hawaii, TMK: (2) 2-3-001:174 and 023 (por.), pursuant to

Section 201H-38, Hawaii Revised Statutes (HRS). The proposed project consists of approximately 116 lots, of which 70 house-lot packages are set aside as affordable or workforce housing. Of the 70 affordable units, 59 are allocated to the Kula Ridge Project, with 11 set aside for the adjacent Kula Ridge Mauka Agricultural Subdivision.

- b. Proposed resolutions to, alternatively, approve the proposed project, approve the proposed project with modifications, and disapprove the proposed project.
2. Correspondence dated September 10, 2010, from the Director of Housing and Human Concerns, transmitting the following:
 - a. A revised proposed resolution entitled "APPROVING THE KULA RIDGE AFFORDABLE HOUSING SUBDIVISION PROJECT PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to approve the proposed project with various exemptions from requirements contained in the Maui County Code and Hawaii Administrative Rules relating to planning, zoning, construction standards for subdivisions, the development and improvement of land, and the construction of dwelling units.
 - b. A proposed resolution entitled "APPROVING WITH MODIFICATION THE KULA RIDGE AFFORDABLE HOUSING SUBDIVISION PROJECT PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to approve the proposed project with the modifications in Exhibit "1" and various exemptions from requirements contained in the Maui County Code and Hawaii Administrative Rules relating to planning, zoning, construction standards for subdivisions, the development and improvement of land, and the construction of dwelling units.
 - c. A proposed resolution entitled "DISAPPROVING THE KULA RIDGE AFFORDABLE HOUSING SUBDIVISION PROJECT PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to disapprove the proposed project.

STATUS: Pursuant to HRS Section 201H-38, the Council shall approve, approve with modification, or disapprove the proposed project by October 22, 2010, or it will be deemed approved. The Committee may consider whether to recommend adoption of a proposed resolution, with or without revisions. The Committee may also consider other related action.
