I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2011-23, PLEA: NO CONTEST

In the matter of the accusation against ZEEBIRD LTD. dba SOUTH SHORE TIKI LOUNGE, Restaurant General License No. 240, 1913-J South Kihei Road, Kihei, Maui, Hawaii.

Count 2. On May 23, 2010 at approximately 9:58 p.m., ZEEBIRD LTD. dba SOUTH SHORE TIKI LOUNGE, a restaurant general licensee, did through its employee(s), fail to immediately prevent or suppress any violent, quarrelsome, disorderly, lewd, immoral, or unlawful conduct of any person on the premises, contrary to Section 281-78(b)(6) of the Hawaii Revised Statutes and Section 08-101-60(b)(6) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2011-28, PLEA: NO CONTEST

In the matter of the accusation against OCEANS II, INC. dba OCEANS BEACH BAR AND GRILL, Dispenser General License No. 375, 1819 South Kihei Road, Bldg A, Kihei, Maui, Hawaii.

Count 1. On August 28, 2010 between the approximate times of 11:32 p.m. and 11:52 p.m., OCEANS II, INC. dba OCEANS BEACH BAR AND GRILL, a dispenser general licensee, did make, cause the making of, continue to make, permit to be made, or permit the continuance of, from its licensed premises or any adjacent premises under the licensee's control, noise which resulted in a complaint from one of more resident(s) or tenant(s) in the vicinity which exceeded the maximum permissible sound levels, contrary to Section 08-101-64 of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2011-29, PLEA: NO CONTEST

In the matter of the accusation against K.S.K. KOREA, INC. dba CLUB KOREANA ARIRANG 1, Dispenser General License No. 111, 1032 Lower

Main Street, Wailuku, Maui, Hawaii.

- Count 1. On July 1, 2010 between the approximate times of 4:33 p.m. and 5:01 p.m., K.S.K. KOREA, INC. dba CLUB KOREANA ARIRANG 1, a dispenser general licensee, did through its employee(s) fail to exercise due care, as defined in Section 08-101-5 of the Rules of the Liquor Commission, in determining whether Chong Su Yi was under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 08-101-60(b)(11) of the Rules of the Liquor Commission, County of Maui.
- Count 2. On July 1, 2010 between the approximate times of 4:33 p.m. and 5:01 p.m., K.S.K. KOREA, INC. dba CLUB KOREANA ARIRANG 1, a dispenser general licensee, did, through its employee(s), knowingly permit Chong Su Yi, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, drugs, as defined in Section 08-101-5 of the Rules of the Liquor Commission, or any combination thereof, or disorderly person, to be or remain in or on the licensed premises, contrary to Section 281-78(b)(5) of the Hawaii Revised Statutes and Section 08-101-60(b)(5) of the Rules of the Liquor Commission, County of Maui.
- Count 3. On July 1, 2010 between the approximate times of 4:33 p.m. and 5:01 p.m., K.S.K. KOREA, INC. dba CLUB KOREANA ARIRANG 1, a dispenser general licensee, did fail to exercise due care to ensure that no person or employee, while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of The Liquor Commission, County of Maui.
