Chair and Members:

Your Infrastructure Management Committee, having met on August 15, 2011, makes reference to County Communication No. 11-174, from Councilmember Mike White, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.095, MAUI COUNTY CODE, TO ESTABLISH PARKING AT THE COUNTY PARKING LOT ON BALDWIN AVENUE IN PAIA, MAUI, HAWAII".

The purpose of the proposed bill is to establish two-hour parking at the County parking lot on Baldwin Avenue in Paia, Maui, Hawaii, from 8:00 a.m. to 6:00 p.m.

The subject parking lot is also known as the Upper Paia municipal parking lot and is located south of the Mana Foods grocery store.

Your Committee noted that Paia merchants and residents support the proposed bill. Your Committee also noted that those who need parking for more than two hours (such as people who work in Paia) may be able to park at the new private parking lot located north of the Patsy Takemoto Mink Post Office. This parking lot has 100 stalls that are available without time limits.

Your Committee voted 7-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Cochran, Vice-Chair Victorino, and members Carroll, Couch, Hokama, Mateo, and Pontanilla voted "aye".

Your Infrastructure Management Committee **RECOMMENDS** the following:

1. That Bill No. _____ (2011), attached hereto, entitled, "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.095, MAUI COUNTY CODE, TO ESTABLISH PARKING AT THE COUNTY PARKING LOT ON BALDWIN AVENUE IN PAIA, MAUI, HAWAII", be **PASSED ON FIRST READING** and be **ORDERED TO PRINT**; and



BILL NO. _____ (2011)

A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.095,
MAUI COUNTY CODE, TO ESTABLISH PARKING AT THE COUNTY
PARKING LOT ON BALDWIN AVENUE IN PAIA, MAUI, HAWAII

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. The purpose of this ordinance is to establish two
hour parking at the County parking lot on Baldwin Avenue in Paia,
from 8:00 a.m. to 6:00 p.m.

SECTION 2. Section 10.48.095, Maui County Code, is amended by
amending subsection A to read as follows:


"A. Makawao District.

1. Baldwin Avenue from Makawao Avenue to
Brewer Road; [and]
2. On the south side of Makawao Avenue
between Olinda Road and Ai Street[.]; and
3. Within the County parking lot on Baldwin
Avenue in Paia."

SECTION 3. Material to be repealed is bracketed. New
material is underscored. In printing this bill, the County Clerk
need not include the brackets, the bracketed material, or the
underscoring.

SECTION 4. This ordinance shall take effect upon its
approval.
