ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. These time limits may be suspended pursuant to the Rules of the Council, provided a suspension would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting, 16 copies are requested.

CENTRAL MAUI RECYCLED WATER VERIFICATION STUDY

DESCRIPTION: The Committee is in receipt of County Communication No. 11-41, from the Director of Environmental Management, transmitting the "Central Maui Recycled Water Verification Study" ("Study") prepared in December 2010 by the Department of Environmental Management and the Department of Water Supply. The purposes of the Study are (1) to identify and evaluate options for upgrading the Kahului Wastewater Reclamation Facility to R-1 water capability; and (2) to identify the location of a recycled water distribution system in the Central Maui area.

STATUS: The Committee may discuss the Study, and related policy issues. The Committee may also consider the filing of County Communication No. 11-41 and other related action
