Chair and Members:

Your Policy Committee, having met on September 14, 2011, makes reference to County Communication 11-31, from Council Chair Danny A. Mateo, relating to the matter of nominations to boards, committees, and commissions (collectively referred to as "boards").

By correspondence dated and received August 17, 2011, the Mayor transmitted a proposed resolution entitled "APPOINTMENT OF MEMBER TO THE SALARY COMMISSION", along with a completed application form for the nominee. The purpose of the proposed resolution is to approve or disapprove the appointment of Edward Tamori to the Salary Commission, for a term expiring on March 31, 2012, to fill an existing vacancy due to the resignation of Juliana Julie M. Higa.

Your Committee notes that general appointment procedures for the boards are provided in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code ("MCC").

Your Committee further notes that specific provisions for the Salary Commission are contained in Sections 2.40.210 and 2.42.010, MCC, and Section 8-18.1, Charter.

Your Committee further notes that the Council must approve or disapprove the nomination by October 16, 2011, or the nomination will be deemed approved.

Your Committee received additional information concerning Mr. Tamori's application, listing various community service organizations on which he has served. Your Committee was satisfied with the information provided and did not request an interview with the nominee.

Your Committee recommended that the proposed resolution be revised by placing the nominee's name and term on Exhibit "B" for approval.



APPOINTMENT OF MEMBER TO THE SALARY COMMISSION

WHEREAS, by letter dated August 17, 2011, Mayor Alan M. Arakawa notified the Council that he nominated the person listed in Exhibit "A", attached hereto, as a member to the Salary Commission, pursuant to Section 8-18(1), Revised Charter of the County of Maui (1983), as amended ("Charter"); and

WHEREAS, Section 13-2 of the Charter requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Section 13-2(17) of the Charter requires the Council to approve or disapprove the nominee within sixty (60) days after the Mayor submits the nominee to the Council; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:
