I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2012-1, PLEA: NO CONTEST

In the matter of the accusation against MULLIGAN'S ON THE BLUE, LLC dba MULLIGAN'S ON THE BLUE, Restaurant General License No. 084, 100 Kaukahi Street, Wailea, Maui, Hawaii.

Count 1. On March 17, 2011 at approximately 10:05 p.m. and 11:32 p.m., MULLIGAN'S ON THE BLUE, LLC dba MULLIGAN'S ON THE BLUE, a restaurant general licensee, did, through their employee(s), fail to ensure that main or primary entrances were unobstructed, and aisles or walkways were cleared of any congestion or blockage which would prevent any person from moving freely within any aisle or walkway, contrary to Section 08-101-90(b) of the Rules of the Liquor Commission, County of Maui.

Count 2. On March 17, 2011 at approximately 10:09 p.m., MULLIGAN'S ON THE BLUE, LLC dba MULLIGAN'S ON THE BLUE, a restaurant general licensee, did, through their employee(s), fail to comply with the condition placed on its liquor license by the commission, contrary to Section 08-101-26(d) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2012-2, PLEA: NO CONTEST

In the matter of the accusation against EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, Dispenser General License No. 350, 333 Dairy Road, Suite 105, Kahului, Maui, Hawaii.

Count 1. On August 16, 2010 at approximately 2:40 p.m., EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, a dispenser general licensee, did fail to have records available for inspection by the Department, contrary to Section 08-101-50(d)(11) of the Rules of the Liquor Commission, County of Maui.

- Count 2. On August 16, 2010 at approximately 2:40 p.m., EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, a dispenser general licensee, did fail to have available on its licensed premises a timesheet showing in English the legal first name and surname of all employees, including and not limited to managers, assistant managers, and employees approved by the director, when such employee is on duty, contrary to Section 08-101-70(f) of the Rules of the Liquor Commission, County of Maui.
