ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be suspended pursuant to the Rules of the Council, provided a suspension would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting, 16 copies are requested.

BILLS RELATING TO STORMWATER RUNOFF

DESCRIPTION:

The Committee is in receipt of County Communication 11-139, from the Director of Public Works, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 16.26, MAUI COUNTY CODE, RELATING TO THE BUILDING CODE". The purpose of the proposed bill is to: a) reduce the pollution associated with stormwater runoff from new developments; b) require that post construction stormwater quality best management practices be implemented; and c) grant the Director of Public Works the authority to adopt administrative rules to implement the stormwater quality requirements.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 18.20, MAUI COUNTY CODE, RELATING TO SUBDIVISION IMPROVEMENTS". The purpose of the proposed bill is to require that post-construction stormwater quality best management practices be implemented by granting the Director of Public Works the authority to adopt administrative rules to implement such practices.

STATUS: The Committee may consider whether to recommend passage of the proposed bills on first reading, with or without revisions. The Committee may also consider the filing of County Communication 11-139 and other related action.
