ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be suspended pursuant to the Rules of the Council, provided a suspension would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting, 16 copies are requested.

SHORT-TERM RENTAL HOMES

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 11-70, from Councilmember Gladys C. Baisa, transmitting a proposed resolution to refer to the planning commissions a proposed bill to permit short-term rental homes in certain areas, subject to appropriate restrictions and standards.
2. Correspondence dated August 23, 2011, from the Planning Director, transmitting comments from the planning commissions and the Hana Advisory Committee in response to Resolution 11-24, entitled "REFERRING TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS A DRAFT BILL AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO SHORT-TERM RENTAL HOMES", adopted on March 18, 2011.

Correspondence dated January 3, 2012, from the Chair of the Committee, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO SHORT-TERM RENTAL HOMES". The purpose of the revised proposed bill is to permit short-term rental homes in certain areas, subject to appropriate restrictions and standards.
