**I. HEARINGS BEFORE THE BOARD:**

**A. Unfinished Business: Penalty**

**COMPLAINT AND ACCUSATION NO. 2012-17, DECISION: GUILTY**

**In the matter of the accusation against CASANOVA, LTD. dba CASANOVA, Restaurant General License No. 010, 1188 Makawao Avenue, Makawao, Maui, Hawaii.**

Count 1. On June 1, 2011 and June 2, 2011 between the approximate times of 10:00 p.m. and 1:00 a.m., CASANOVA, LTD. dba CASANOVA, a restaurant general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Jessica Weatherholt, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

**B. COMPLAINT AND ACCUSATION NO. 2012-21, PLEA: NO CONTEST**

**In the matter of the accusation against LAHAINA CAFE LLC dba LAHAINA CAFE, Dispenser General License No. 212, 843 Wainee Street, Bldg F, Units 1 & 2, Lahaina, Maui, Hawaii.**

Count 1. On April 20, 2011 at approximately 10:17 p.m., LAHAINA CAFE LLC dba LAHAINA CAFE, a dispenser general licensee, did fail to exercise due care to ensure that no person or employee, while on duty, be permitted to consume any alcoholic beverages, contrary to

Section 08-101-80(a)(1) of the Rules of the Liquor Commission, County of Maui.

- Count 2. On April 20, 2011 at approximately 10:17 p.m., LAHAINA CAFE LLC dba LAHAINA CAFE, a dispenser general licensee, did fail to have available on its licensed premises a timesheet showing in English the legal first name and surname of all employees, and time record entries when the employee reports on duty and again when the employee goes off duty, contrary to Section 08-101-70(f) of the Rules of the Liquor Commission, County of Maui.

**C. COMPLAINT AND ACCUSATION NO. 2012-22, PLEA: NO CONTEST**

**In the matter of the accusation against THREE'S CATERING LLC dba THREE'S BAR AND GRILL, Dispenser General License #178, 1945-G South Kihei Road, Kihei, Maui, Hawaii.**

- Count 1. On August 5, 2011 at approximately 1:03 a.m., THREE'S CATERING LLC dba THREE'S BAR AND GRILL, a dispenser general licensee, did fail to exercise due care to ensure that no person or employee, while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of the Liquor Commission, County of Maui.

**D. COMPLAINT AND ACCUSATION NO. 2012-23, PLEA: NO CONTEST**

**In the matter of the accusation against KIHEI BOYS CLUB LLC dba SANSEI SEAFOOD RESTAURANT & SUSHI BAR, Restaurant General License No. 124, 1881 South Kihei Road, Unit #KT-116, Kihei, Maui, Hawaii.**

- Count 1. On August 26, 2011 at approximately 8:55 p.m., KIHEI BOYS CLUB LLC dba SANSEI SEAFOOD RESTAURANT & SUSHI BAR, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**E. COMPLAINT AND ACCUSATION NO. 2012-24, PLEA: NO CONTEST**

**In the matter of the accusation against HAU I INC. dba HAU I'S LIFE'S A BEACH, Dispenser General License No. 022, 1913 South Kihei Road, Space E, Kihei, Maui, Hawaii.**

- Count 1. On August 26, 2011 at approximately 10:52 p.m., HAU I INC. dba HAU I'S LIFE'S A BEACH, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
