GENERAL PLAN UPDATE (MAUI ISLAND PLAN: CHAPTER 8 (DIRECTED GROWTH PLAN) - (KIHEI-MAKENA REGION and MAKAWAO-PUKALANI-KULA REGION))

DESCRIPTION:

The Committee is in receipt of the following:

1. Correspondence dated October 16, 2009, from Council Chair Danny A. Mateo, transmitting the draft Maui Island Plan and the related recommendations of the Planning Director, the Maui General Plan Advisory Committee, and the Maui Planning Commission, submitted by the Department of Planning pursuant to Chapter 2.80B, Maui County Code.

The purpose of the proposed resolution is to extend the deadline of August 3, 2012 (established by Resolution 11-129), to December 31, 2012.

STATUS: The Committee may proceed as follows:

1. The Committee will base its deliberations for Chapter 8 (Directed Growth Plan) of the consolidated draft Maui Island Plan on the updated version transmitted by the Planning Director by correspondence dated December 3, 2010 (referenced in paragraph 5 of the above "DESCRIPTION"). Revisions to Chapter 8 may be considered on the basis of motions made by Committee members. The Committee may review, revise, and recommend approval of the following portions of the Directed Growth Plan:
 - a. The Kihei-Makena region at pages 8-23 through 8-30 and maps C4, C5, and S1 through S3; and
 - b. The Makawao-Pukalani-Kula region at pages 8-30 through 8-35 and maps U1 through U4.
2. The Committee may consider whether to recommend adoption of the proposed resolution referenced in paragraph 9 of the above "DESCRIPTION", with or without revisions.
