THE REGULAR MEETING OF THE COUNCIL OF THE COUNTY OF MAUI, STATE OF HAWAII, WAS HELD IN THE COUNCIL CHAMBER, KALANA O MAUI BUILDING, WAILUKU, HAWAII, ON FRIDAY, JUNE 15, 2012, BEGINNING AT 9:04 A.M., WITH VICE-CHAIR JOSEPH PONTANILLA PRESIDING.

As a Law Clerk, she developed her skills in research, writing, and preparing oral arguments. Since 2008, she has been employed as a Hawaii State Public Defender.

I had the opportunity to interview her along with other two finalists. Each of the finalists possessed the legal background skills and abilities we're looking for; however, she was the best fit for the position. She is a go-getter who will fit in with our staff and Councilmembers. I think that she'll be, that we'll be very fortunate to have her on our team. Unfortunately, she was unable to attend today's meeting

because of course like good, any good attorney, she's in court. I urge my support for the resolution.


