ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be modified pursuant to the Rules of the Council, provided a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting, 16 copies are requested to ensure distribution at the meeting.

WATER CONSERVATION PLAN

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 11-307, from Councilmember Michael P. Victorino, transmitting a proposed bill to (1) establish a water conservation plan, and (2) amend Title 14 to delete the section relating to water source development agreements with private entities and add it as a new chapter in the Maui County Code.
2. Correspondence dated July 9, 2012, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 14.03.020, MAUI COUNTY CODE, RELATING TO WATER CONSERVATION PLAN DEADLINES".

The purpose of the proposed bill is to extend the deadline for the Council's enactment of a Water Conservation Plan to August 30, 2013.

3. Correspondence dated July 13, 2012, from the Director of Water Supply, responding to an inquiry from the Chair of the Committee, relating to County toilets, flushing consumption of toilets, and an amendment to the Uniform Plumbing Code.

STATUS:

The Committee may consider whether to recommend passage of the proposed bill noted in paragraph 2 above on first reading, with or without revisions. The Committee may also discuss water conservation technology and related policy matters, the filing of County Communication 11-307, and other related action.
