Chair and Members:

Your Planning Committee, having met on January 31, 2013, makes reference to County Communication 13-39, from Councilmember Donald G. Couch, Jr., transmitting a proposed resolution entitled "APPROVING THE ORDER OF THE NINE COMMUNITY PLANS FOR THE 2030 GENERAL PLAN UPDATE".

The purpose of the proposed resolution is to establish the order of the decennial updates to the nine community plans as follows: Lanai, West Maui, Kihei-Makena, Wailuku-Kahului, Makawao-Pukalani-Kula, Paia-Haiku, Hana, Molokai, and Kahoolawe.

Your Committee notes that by Resolution 10-64, the Council approved the order of the first four community plans to be considered as part of the 2030 General Plan Update as follows: Molokai, Lanai, Hana, and West Maui. The proposed resolution is intended to supersede Resolution 10-64.

A representative from the Department of Planning informed your Committee that the Lanai Community Plan Advisory Committee has been established, and the Department has invested a substantial amount of resources to update both the Lanai and Molokai Community Plans. The Department's policy recommendations for Molokai are based on technical studies, and public input that has already been received. If the Department must update other community plans to conform to the order in the proposed resolution, it may be years before the Department completes the Molokai Community Plan, and the plan would contain outdated information.

Your Committee voted to revise the order of the nine community plan updates as follows: Lanai, Molokai, West Maui, Kihei-Makena, Wailuku-Kahului, Makawao-Pukalani-Kula, Paia-Haiku, Hana, and Kahoolawe.

Your Committee voted 7-0 to recommend adoption of the revised proposed resolution and filing of the communication. Committee Chair Couch, Vice-Chair Victorino, and members Baisa, Cochran, Crivello, Guzman, and White voted "aye".

WHEREAS, the Council wishes to revise the order of the first four community plan updates and establish the order for all nine community plan updates; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:
