Chair and Members:

Your Economic Development, Energy, Agriculture, and Recreation Committee, having met on June 18, 2013, makes reference to County Communication 13-134, from the Director of Public Works, transmitting a proposed bill entitled “A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME WAIHEE (BALL) PARK IN WAILUKU TO THE RICHARD “PABLO” CALDITO PARK”.

The purpose of the proposed bill is to pay tribute to Richard “Pablo” Caldito Sr. by renaming Waihee (Ball) Park after him.

The Deputy Director of Public Works provided your Committee with a brief historical overview of the life and contributions of Richard “Pablo” Caldito Sr. to Maui County. Mr. Caldito served for 15 years as an elected official for Maui County, becoming the first Filipino-American Democratic candidate to be elected to public office in the nation. Mr. Caldito also impacted the community and young leaders in Maui County through his service in various organizations, including the Maui Lions Club, Maui Children’s Home, Maui Adult Daycare Center, and the Maui Filipino Chamber of Commerce.

The Deputy Director of Public Works also noted the Commission on Naming Streets, Parks, and Facilities and the Waihee Community Association recommended approval of renaming the Waihee (Ball) Park located at Halewaiu Road and Kahekili Highway, Wailuku, Maui, Hawaii, to the Richard “Pablo” Caldito Park.

Your Committee notes its appreciation for Richard “Pablo” Caldito Sr.’s leadership and service to the community, and his exemplary years of service on the Maui County Board of Supervisors and the Maui County Council.

Your Economic Development, Energy, Agriculture, and Recreation Committee RECOMMENDS the following:



BILL NO. _____ (2013)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40,
MAUI COUNTY CODE, TO RENAME WAIHEE (BALL) PARK
IN WAILUKU TO THE RICHARD "PABLO" CALDITO PARK

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Chapter 12.40, Maui County Code, is amended by
adding a new section to be designated and to read as follows:

"12.40.230 Richard "Pablo" Caldito Park. Richard
"Pablo" Caldito Park shall refer to the area formerly
known as the Waihee (Ball) Park, and identified as
TMK: (2) 3-2-012:002, Halewaiu Road and Kahekili
Highway, Wailuku, Hawaii."

SECTION 2. In printing this bill, the County Clerk need
not include the underscoring.

SECTION 3. This ordinance shall take effect upon its
approval.
