(MAUI COUNTY CULTURAL RESOURCES COMMISSION)**

**DESCRIPTION:** The Committee is in receipt of correspondence dated July 1, 2013, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 2012-1000-15, JAMES J. The claim alleges the County overcharged Waiehu Golf Shop, Inc. for electricity and related matters while it operated a concession at the Waiehu Golf Course. **DESCRIPTION:** The Committee is in receipt of correspondence dated July 22, 2013, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF AMERICAN CIVIL LIBERTIES UNION OF HAWAII, ET AL. V. COUNTY OF MAUI, CIVIL NO. CV13-00307 LEK KSC" and transmitting a copy of the complaint. The complaint alleges that on or about January 21, 2013, the County violated Mele Stokesberry's and Charles M. Carletta's constitutional rights to free speech. The purpose of the proposed resolution is to authorize settlement of the case for \$15,000.

COUNTY OF MAUI, CIVIL NO. 09-1-0127(1)" and transmitting a copy of the complaint. The complaint alleges that on January 24, 2009, Kay Burke suffered physical injuries when she tripped and fell on a sidewalk, which was maintained by the County, fronting the Maui Vista Condominium along South Kihei Road, Kihei. The purpose of the proposed resolution is to authorize settlement of the case.

**DESCRIPTION:** The Committee is in receipt of correspondence dated July 31, 2013, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 2012-1022-21 OF LIBERTY MUTUAL FIRE INSURANCE COMPANY ON BEHALF OF ITS INSURED, ERIC STEVENSON" and transmitting a copy of the claim. The claim alleges damages to the vehicle of Eric Stevenson when a County refuse truck collided with his vehicle while it was parked at Kupuna Street, Kihei, on November 1, 2012. The purpose of the proposed resolution is to authorize settlement of the claim for \$8,371.82.

**DESCRIPTION:** The Committee is in receipt of a Miscellaneous Communication, dated July 9, 2013, from the County Clerk, transmitting certified copies of the following:

Resolution 13-83, entitled "AUTHORIZING THE POLICY AND INTERGOVERNMENTAL AFFAIRS COMMITTEE TO CONDUCT A FORMAL INVESTIGATION OF THE DEPARTMENT OF MANAGEMENT; DEPARTMENT OF FINANCE; BUDGET OFFICE, OFFICE OF THE MAYOR; DEPARTMENT OF PUBLIC WORKS; AND DEPARTMENT OF THE CORPORATION COUNSEL", which was adopted by the Council on July 5, 2013.
