AGENDA ITEMS ARE SUBJECT TO CANCELLATION. ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be modified pursuant to the Rules of the Council, provided a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting site, 16 copies are requested to ensure distribution at the meeting.

REMOTE TESTIMONY SITES: Oral testimony may be received by telephone from each of the Council district offices noted above. If the audio connection between the meeting site in the Council Chamber and any of the remote testimony sites is lost, the meeting in the Council Chamber will still continue. Members of the public interested in information about offering testimony on an agenda item from a remote testimony site may contact the Office of Council Services prior to the meeting. While oral testimony is being received, the district offices cannot provide other services. The audio connection will be terminated after all oral testimony has been received.

INDIVIDUALS WHO INTEND TO ATTEND THE MEETING AND WHO HAVE DISABILITIES REQUIRING SPECIAL ASSISTANCE should call the Office of Council Services at least three days in advance.

EAR-1(1) COMMITTEE'S PRIORITIES AND PROCEDURES; PRESENTATIONS FROM COUNTY ADMINISTRATIVE AGENCIES (ORIENTATION WORKSHOP BY THE DEPARTMENT OF PARKS AND RECREATION)

DESCRIPTION: Pursuant to Rule 7(B) of the Rules of the Council, the Committee intends to have an orientation workshop conducted by the Department of Parks and Recreation. The workshop may cover such topics as the results of the Department's recent online public survey to gather community input on how the Department can improve park facilities and recreational programs.

STATUS: The Committee may receive a presentation from the Department of Parks and Recreation. No legislative action will be taken.

EAR-1(2) COMMITTEE'S PRIORITIES AND PROCEDURES; PRESENTATIONS FROM COUNTY ADMINISTRATIVE AGENCIES (ORIENTATION WORKSHOP BY THE OFFICE OF ECONOMIC DEVELOPMENT)

DESCRIPTION: Pursuant to Rule 7(B) of the Rules of the Council, the Committee intends to have an orientation workshop conducted by the Office of Economic Development. The workshop may cover such topics as office administration, business development in Maui County, and updates on the Economic Development Revolving Fund.

STATUS: The Committee may receive a presentation from the Office of Economic Development. No legislative action will be taken.

EAR-18 NAMING THE PROPOSED NAHIKU COMMUNITY CENTER "DAVID KANALOA KAHO'OKELE JR. NAHIKU COMMUNITY CENTER"

DESCRIPTION: The Committee is in receipt of County Communication 13-277, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO NAME THE PROPOSED NAHIKU COMMUNITY CENTER IN NAHIKU THE DAVID KANALOA KAHO'OKELE JR. NAHIKU COMMUNITY CENTER". The purpose of the proposed bill is to pay tribute to David Kanaloa Kaho'okele Jr. by naming the proposed Nahiku Community Center after him.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 13-277 and other related action.

EAR-17 TREE PROTECTION

DESCRIPTION: The Committee is in receipt of County Communication 13-220, from Council Vice-Chair Robert Carroll, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.24A, MAUI COUNTY CODE, RELATING TO LANDSCAPE PLANTING AND BEAUTIFICATION". The purpose of the proposed bill is to establish standards and procedures to minimize the removal and loss of trees within the County.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 13-220 and other related action.
