**I. HEARINGS BEFORE THE BOARD:**

**A. COMPLAINT AND ACCUSATION NO. 2013-47, PLEA: NO CONTEST**

**In the matter of the accusation against FS LANAI INC. dba FOUR SEASONS RESORT LĀNA'I, THE LODGE AT KOELE, Hotel License No. 067, 1 Keomuku Highway, Koele, Lanai, Hawaii.**

Count 1. On August 17, 2012 at approximately 1:08 p.m., FS LANAI INC. dba FOUR SEASONS RESORT LĀNA'I, THE LODGE AT KOELE, a hotel licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**B. COMPLAINT AND ACCUSATION NO. 2013-54, PLEA: NO CONTEST**

**In the matter of the accusation against MAUI INTERNATIONAL ENTERTAINMENT, LLC dba FLEETWOOD'S ON FRONT ST., Dispenser General License No. 059, 744 Front Street, Lahaina, Maui, Hawaii.**

Count 1. On December 15, 2012 between the approximate times of 10:03 p.m. and 10:23 p.m.; on December 21, 2012 between the approximate times of 10:10 p.m. and 10:30 p.m.; and on December 22, 2012 between the approximate times of 10:10 p.m. and 10:30 p.m., MAUI INTERNATIONAL ENTERTAINMENT, LLC dba FLEETWOOD'S ON FRONT ST., a dispenser general licensee, did make, cause the making of, continue to make, permit to be made, or permit the continuance of, from its licensed premises or any adjacent premises under the licensee's control, noise which resulted in a complaint from one or more resident(s) or tenant(s) in the vicinity which exceeded the maximum permissible sound levels, contrary to Section 08-101-64 of the Rules of the Liquor Commission, County of Maui.
