Chair and Members:

Your Policy and Intergovernmental Affairs Committee, having met on February 7, 2014, makes reference to County Communication 13-41, from Council Chair Gladys C. Baisa, regarding litigation matters.

By correspondence dated January 29, 2014, the Department of the Corporation Counsel requested consideration of the possible settlement of Jonathan Preza v. County of Maui, Disability Compensation Division Case 7-10-00655. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF JONATHAN PREZA V. COUNTY OF MAUI, CASE NO. 7-10-00655". The purpose of the proposed resolution is to authorize the Department of the Corporation Counsel to settle the case.

Your Committee notes Section 3.16.020(A), Maui County Code, requires Council authorization for any settlement of a workers' compensation claim in excess of the authority granted by that provision.

A Deputy Corporation Counsel explained the case involves a workers' compensation claim brought by Jonathan Preza, a Captain with the Department of Fire and Public Safety. According to the Deputy, Captain Preza alleged work-related injuries sustained on March 29, 2010. Because the case involves ongoing litigation and confidential medical information, the Deputy requested the opportunity to convene an executive meeting.

Your Committee voted to convene an executive meeting, closed to the public, to consult with legal counsel pursuant to Section 92-5(a)(4), Hawaii Revised Statutes; and to deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a State or Federal law, or a court order, pursuant to Section 92-5(a)(8), Hawaii Revised Statutes.



WHEREAS, Claimant Jonathan Preza filed a Workers' Compensation Claim alleging work-related injuries sustained on March 29, 2010; and

WHEREAS, having reviewed the facts and circumstances regarding this matter and being advised of the proposed settlement by the Department of the Corporation Counsel, the Council wishes to authorize the settlement of the Workers' Compensation Claim under the terms and conditions as proposed in an executive meeting before the Policy and Intergovernmental Affairs Committee; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby approves the settlement of Jonathan Preza v. County of Maui, Disability Compensation Division Case No. 7-10-00655, under the terms set forth in an executive meeting before the Policy and Intergovernmental Affairs Committee; and

2. That it hereby authorizes the Mayor to execute a Stipulation and Settlement Agreement on behalf of the County in this case; and

3. That it hereby authorizes the Director of Finance of the County of Maui to satisfy said settlement of this case, under such


