ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be modified pursuant to the Rules of the Council, provided a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting site, 16 copies are requested to ensure distribution at the meeting.

REMOTE TESTIMONY SITES: Oral testimony may be received by telephone from each of the Council district offices noted above. If the audio connection between the meeting site in the Council Chamber and any of the remote testimony sites is lost, the meeting in the Council Chamber will still continue. Members of the public interested in information about offering testimony on an agenda item from a remote testimony site may contact the Office of Council Services prior to the meeting. While oral testimony is being received, the district offices cannot provide other services. The audio connection will be terminated after all oral testimony has been received.

EAR-33 AMENDING SECTION 13.04.020, MAUI COUNTY CODE, TO AMEND THE DEFINITION OF OCEAN RECREATIONAL ACTIVITY

DESCRIPTION: The Committee is in receipt of County Communication 14-33, from Councilmember Mike White, transmitting a proposed bill, entitled “A BILL FOR AN ORDINANCE AMENDING SECTION 13.04.020, MAUI COUNTY CODE, TO AMEND THE DEFINITION OF OCEAN RECREATIONAL ACTIVITY BY ADDING TO THE LIST OF ACTIVITIES TO BE INCLUDED”. The purpose of the proposed bill is to amend Section 13.04.020, Maui County Code, to add “canoeing” as an ocean recreation activity.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 14-33 and other related action.

EAR-34 RENAMING THE EDDIE TAM COMPLEX FIELD 6 TO THE WILLIAM “BLEE” AMORAL SR. FIELD (MAKAWAO)

DESCRIPTION: The Committee is in receipt of County Communication 14-47, from the Director of Public Works, transmitting a proposed bill, entitled “A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME THE EDDIE TAM COMPLEX FIELD #6 IN MAKAWAO TO THE WILLIAM “BLEE” AMORAL SR. FIELD”. The purpose of the proposed bill is to rename Field 6 at the Eddie Tam Complex in Makawao, Hawaii, the William “Blee” Amoral Sr. Field.

EAR-13 ROADSIDE STANDS AND FARMER’S MARKETS IN THE AGRICULTURAL DISTRICTS

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication 13-85, from Councilmember Elle Cochran, transmitting a proposed resolution referring a proposed bill relating to roadside stands and farmer’s markets in the Agricultural Districts, to the Lanai, Maui, and Molokai Planning Commissions.
2. Correspondence dated February 21, 2014, from Committee Chair Don S. Guzman, transmitting a proposed resolution, entitled “REFERRING TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS A PROPOSED BILL TO AMEND SECTION 19.04.040 AND CHAPTER 19.30A, MAUI COUNTY CODE, PERTAINING TO COMMERCIAL AGRICULTURAL STRUCTURES IN THE AGRICULTURAL DISTRICT”. The purpose of the proposed resolution is to refer to the planning commissions a proposed bill, entitled “A BILL FOR AN ORDINANCE AMENDING SECTION 19.04.040 AND CHAPTER 19.30A, MAUI COUNTY CODE, PERTAINING TO COMMERCIAL AGRICULTURAL STRUCTURES IN THE AGRICULTURAL DISTRICT”. The purpose of the proposed bill is to allow commercial agricultural structures within the Agricultural Districts as an accessory use and special use, subject to appropriate restrictions and standards.

STATUS: The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.

EAR-36 PROHIBITING TOBACCO USE AND TOBACCO PRODUCTS IN COUNTY PARKS**DESCRIPTION:**

1. County Communication 14-49, from Councilmember Don S. Guzman, transmitting a proposed bill prohibiting tobacco use and tobacco products in County parks.
2. Correspondence dated March 3, 2014, from the Department of the Corporation Counsel, transmitting a revised proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 13.04, MAUI COUNTY CODE, PROHIBITING TOBACCO USE AND TOBACCO PRODUCTS IN COUNTY PARKS". The purpose of the proposed bill is to prohibit the use of tobacco, tobacco products, and electronic smoking devices in County of Maui parks.
