Chair and Members:

Your Economic Development, Energy, Agriculture, and Recreation Committee, having met on March 14, 2014, and March 21, 2014, makes reference to County Communication 14-47, from the Director of Public Works, transmitting a proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME THE EDDIE TAM COMPLEX FIELD #6 IN MAKAWAO TO THE WILLIAM "BLEE" AMORAL SR. FIELD".

The purpose of the proposed bill is to rename Field 6 at the Eddie Tam Complex in Makawao, Hawaii, the William "Blee" Amoral Sr. Field.

Pursuant to Section 2.38.090, Maui County Code, the Director of Public Works transmitted a recommendation of approval from the Commission on Naming Streets, Parks, and Facilities that the Eddie Tam Complex Field 6 be renamed after William "Blee" Amoral, Sr.

Your Committee notes Mr. Amoral began his career at Eddie Tam Memorial Complex in 1967. As Supervisor of Recreation at the Complex, he initiated basketball, football, volleyball, baseball, and softball programs. He oversaw the Upcountry track meets and was instrumental in organizing the Makawao Recreational Council. Mr. Amoral died May 25, 2010.

The Deputy Director of Public Works informed your Committee the standards and criteria for naming parks and facilities pursuant to Section 2.38.070, Maui County Code, have been met.

Your Committee voted 4-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Guzman, and members Crivello, Cochran, and White voted "aye". Committee Vice-Chair Carroll, and members Baisa and Victorino were excused.

A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40,  
MAUI COUNTY CODE, TO RENAME THE EDDIE TAM COMPLEX FIELD #6  
IN MAKAWAO TO THE WILLIAM "BLEE" AMORAL SR. FIELD

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Chapter 12.40, Maui County Code, is amended by  
adding a new section to be designated and to read as follows:

"12.40.250 William "Blee" Amoral Sr. Field. The  
field located at 931 Makawao Avenue, Makawao, Hawaii,  
and identified as Field #6 on the Eddie Tam Complex,  
shall be referred to as the William "Blee" Amoral Sr.  
Field."

SECTION 2. In printing this bill, the County Clerk need not  
include the underscoring.

SECTION 3. This ordinance shall take effect upon its  
approval.
