**PIA-2(26) NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS  
(LANAI PLANNING COMMISSION)**

**DESCRIPTION:** The Committee is in receipt of correspondence dated June 6, 2014 (received June 6, 2014), from the Mayor, transmitting a proposed resolution entitled "APPOINTMENT OF A MEMBER TO THE LANAI PLANNING COMMISSION", along with a completed application form for the nominee. The purpose of the proposed resolution is to approve or disapprove the appointment of Romeo Eleno to the Lanai Planning Commission, for a term expiring on March 31, 2017, to fill a vacancy due to the resignation of Priscilla Felipe.

**STATUS:** The Council must approve or disapprove the nomination to the Lanai Planning Commission by August 5, 2014, or the nomination will be deemed approved. The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.

**PIA-2(31) NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS

Buchanan, Steve Chaikin, Zhanell Dudoit, Lance ("Kip") Dunbar, Gregory E. Jenkins, Debra N. Kelly, Shannon M. Kino, Robert A. Stephenson, and Glenn Teves.

## **PIA-69                      BALANCED GEOGRAPHIC REPRESENTATION ON SPECIFIED COUNTY BOARDS AND COMMISSIONS**

**DESCRIPTION:** The Committee is in receipt of County Communication 14-129, from Councilmember G. Riki Hokama, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.41, MAUI COUNTY CODE, TO REQUIRE SPECIFIED COUNTY BOARDS AND COMMISSIONS TO INCLUDE MEMBERS FROM LANAI AND MOLOKAI". The purpose of the proposed bill is to amend Chapter 2.41, Maui County Code, to add a new Section 2.41.080, "Balanced geographic representation", to require that a minimum of one member shall be a resident of Lanai and a minimum of one member shall be a resident of Molokai for each of the following boards and commissions: Board of Variances and Appeals, Cost of Government Commission, Fire and Public Safety Commission, Liquor Control Adjudication Board, Liquor Control Commission, and Police Commission.
