III. APPROVAL OF MINUTES: April 10, 2014 meeting.

a. Commissioner Valentine MOVED to approve the minutes without amendment. Commissioner Laemoa SECONDED. MOTION CARRIED.

IV. CORRESPONDENCE

- a. Mayor's response to Commission's December 23, 2013 letter to Mayor requesting all systems monthly pass for riders with disabilities.
 - Commissioners reviewed the letters and the gist was that the county could not reduce fares.
 - ii. Commissioner Valentine was concerned the letter to the mayor did not accurately convey the commission's intentions.

- b. Email dated 4/11/14 from Office of Information Practices on meeting by interactive conference technology.
 - i. Commissioners with disabilities may attend meetings via Skype or Google Plus IF the reason they cannot attend is related to their disability – not if there were no flights available, for instance.
 - ii. Deputy Corporation Council will clarify at next meeting under what conditions meeting can continue should either audio or visual lost.
 - iii. Staff will check on technologies needed for the meeting.
 - iv. Chair Gaxiola asked commissioners not to get bagged down with one, two or three people when the goal of the commission is to help the community of thousands.

V. PUBLIC TESTIMONY ON AGENDA ITEMS AND COMMUNITY CONCERNS AS THEY PERTAIN TO ISSUES AFFECTING PERSONS WITH DISAILITIES

a. Vivian Lindsey stated that the bus system wastes fuel by criscrossing the island with empty buses and it would save money by allowing riders with monthly passes to ride any of the routes – fixed route or para transit. It would also save persons with disabilities time in transiting from home to central and back. She stated that this is allowed for seniors and students but not disabled.

VI. NEW BUSINESS

- a. Goal Setting
 - i. Commissioners discussed and determined that they would focus on two issues before moving to other issues:
 - 1. Para Transit issue
 - 2. Emergency evacuation of disabled.
 - ii. Commissioner Laemoa MOVED Commissioner Valentine SECONDED and MOTION CARRIED as follows:
 - 1. To have commission focus on the two issues of Para Transit and Transportation of persons with disabilities when an evacuation is declared;
 - 2. To send a letter to the Mayor via the Director of Housing and Human Concerns to request the

Department of Transportation and Civil Defense agency assign a staff person to attend and facilitate the subjects of Para Transit and Transportation of persons with disabilities when an evacuation is declared at the commission's regular meetings.

3. To have Staff compose the letter that will include a deadline for response to the letter.

b. Election of Officers

- Commissioner Valentine MOVED to nominate Commissioner Laemoa to serve as Commission Chair. Commissioner Tomita SECONDED. Commissioner Laemoa MOVED to nominate Commissioner Sabado to serve as Vice Chair. Commissioner Sabado SECONDED.
- Commissioner Valentine MOVED to accept and close the nominations. Commissioner Sabado SECONDED. MOTIN CARRIED.
