ORAL OR WRITTEN TESTIMONY on any agenda item will be accepted. Each testifier shall be allowed to speak for three minutes on each item. If additional time is requested, the testifier shall be allowed one minute to conclude the testimony on the item. These time limits may be modified pursuant to the Rules of the Council, provided a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify shall be deemed withdrawn if the individual does not answer when called to testify. To ensure its distribution prior to the meeting, written testimony must be received in the Office of Council Services at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting. If written testimony is submitted at the meeting site, 16 copies are requested to ensure distribution at the meeting.

REMOTE TESTIMONY SITES: Oral testimony may be received by telephone from each of the Council district offices noted above. If the audio connection between the meeting site in the Council Chamber and any of the remote testimony sites is lost, the meeting in the Council Chamber will still continue. Members of the public interested in information about offering testimony on an agenda item from a remote testimony site may contact the Office of Council Services prior to the meeting. While oral testimony is being received, the district offices cannot provide other services. The audio connection will be terminated after all oral testimony has been received.

IEM-4 BICYCLE AND BICYCLE TOUR SAFETY ON MAUI ROADS

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 13-59, from Council Chair Gladys C. Baisa, relating to the matter of bicycle and bicycle tour safety on Maui roads.
2. Correspondence dated October 28, 2013, from the Director of Public Works, transmitting a proposed bill relating to regulation of bicycle tour businesses.
3. Correspondence dated September 29, 2014, from the Committee Chair Elle Cochran, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE RELATING TO REGULATION OF BICYCLE TOUR BUSINESSES". The purpose of the proposed bill is to revise the regulations pertaining to bicycle tour businesses by increasing permit requirements, expanding enforcement capabilities, and establishing an appeals process.

STATUS:

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of County Communication 13-59 and other related action.

IEM-37 PRINCIPLES OF ZERO WASTE AS A WASTE MANAGEMENT POLICY FOR THE COUNTY OF MAUI

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 13-33, from Councilmember Michael P. Victorino, transmitting a proposed resolution relating to the principles of zero waste.
2. Correspondence dated October 6, 2014, from the Committee Chair Elle Cochran, transmitting a revised proposed resolution entitled "URGING THE DEPARTMENT OF ENVIRONMENTAL MANAGEMENT TO ESTABLISH A ZERO WASTE PLAN FOR THE COUNTY OF MAUI". The purpose of the proposed resolution is to urge the Department of Environmental Management to develop a zero waste plan and to encourage zero waste practices in the County of Maui.

STATUS:

The Committee may consider whether to recommend adoption of the revised proposed resolution, with or without revisions. The Committee may also consider the filing of County Communication 13-33 and other related action.
